period to June 30, 1983, with no increase in the contract amount.

VOTED: That the Secretary is authorized to advertise for bids

On motion duly made and seconded, it was unanimously

VOTED: That the Director be, and hereby is, authorized to enter into a personal services contract with Barry Abramson to provide economic and development planning services to the Authority for a period of not more than three months, for a contract amount of not more than \$7,500, to become effective upon the expiration of his present contract, using Federal Highway Administration funds.

Copies of a memorandum dated December 15, 1982 were distributed re Extension of Time for S. G. Associates Contract, which included a proposed vote.

On motion duly made and seconded, it was unanimously

VOTED: That the Director be, and hereby is, authorized to amend

the Authority's contract with S. G. Associates of Boston,

to extend the period of contract time to March 1, 1983, with no increase in the contract amount.

Copies of a memorandum dated December 15, 1982 were distributed re Authorization to Submit a Grant Application to The National Endowment for the Arts re Upgrading of Copley Square, attached to which were copies of a page of the grant application and a proposed vote.

On motion duly made and seconded, it was unanimously

VOTED: That the Director be, and hereby is, authorized to transmit a grant application to seek up to \$30,000 in National Endowment for the Arts funds which, when granted, will be matched by an equal amount of private capital; said grant funds to be utilized to conduct a feasibility analysis for the redesign of Copley Square.

VOTED: In reference to Petition Z-5937, Happy Hour of Roslindale,
Inc., 4187-4195 Washington Street, Roslindale, for forbidden
use for change of occupancy from restaurant to restaurant
with entertainment (four video game and two pinball
machines) in a local business (L-1) district, the Boston
Redevelopment Authority requests the Board of Appeal
defer action until the Authority has further opportunity
to review the situation.
