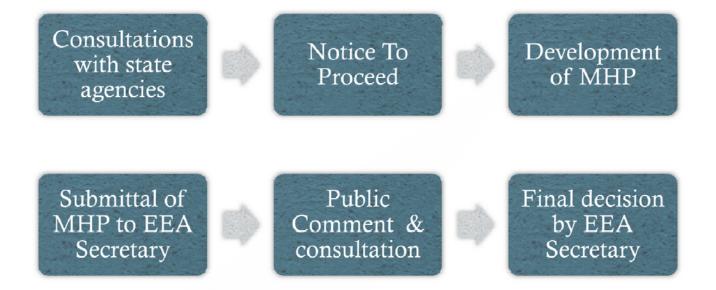

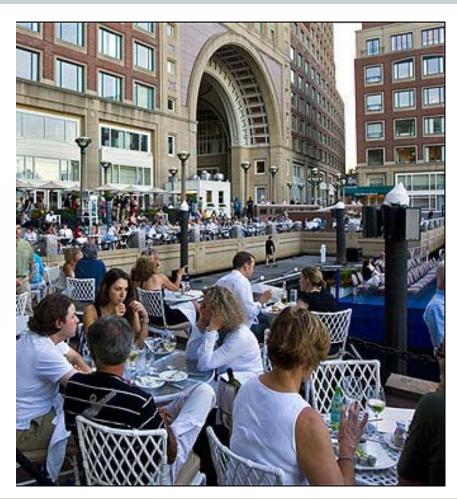








- A Request for a Notice To Proceed
 (RNTP) initiates the NTP process
- The purpose of an RNTP is to:
 - ➤ Provide an overview of the City's approach to an MHP;
 - ➤ Identify potential planning issues and opportunities; and
 - ➤ Involve the public
- An RNTP should be flexible enough to accommodate a broad array of potential outcomes







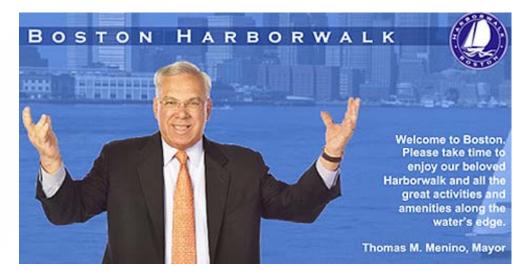
An RNTP must include:

- The MHP objectives;
- A description of the proposed MHP analysis;
- A broad-based public participation program;
- A history of uses and development;
- A review of prior planning efforts;
- A list of the MHP Advisory
 Committee, staff, & consultants; and
- A map of the harbor planning area



The objectives in the City's draft RNTP are to:

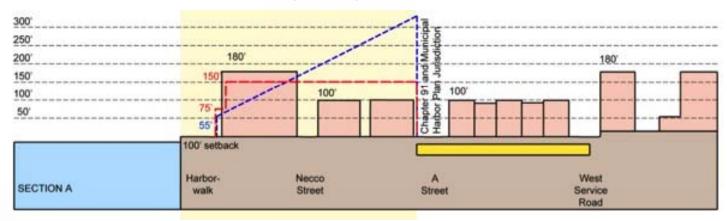
- •Continue to Develop the District as an Active, Mixed Use Area that is an Integral Part of Boston's Economy;
- •Promote Access to Boston Harbor, the Harbor Islands & Water Transportation;
- •Improve Waterfront Wayfinding and Open Space Connections;
- Enhance Open Space
 Resources & the Public Realm;
- Create a Climate Resilient Waterfront; and
- Implement the Greenway
 Study Wharf District
 Guidelines [zoning]





The proposed MHP planning analysis reflects the City's objectives for the Downtown Waterfront Area and states how the City will:

- •Address/assess potential issues; and
- •Assess alternatives, including substitute provisions
 - Example: comparison of the impacts of a proposed development with a Chapter 91-compliant alternative, as was used for the Fort Point Channel MHP (below)



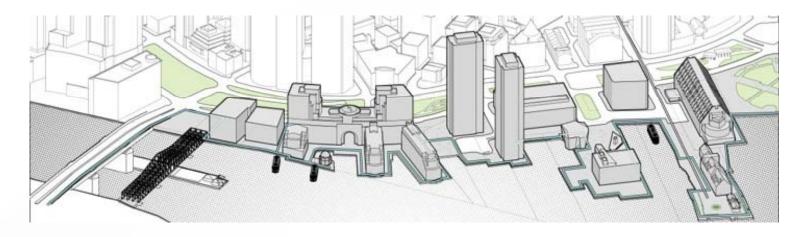


- A broad-based public participation program that includes early & continuing interaction with:
 - > the MHPAC and the general public;
 - ➤ appropriate government agencies, boards, and officials, including the Department of Environmental Protection (DEP) and the Office of Coastal Zone Management (CZM); and
 - > other affected state, regional, and federal agencies





- A draft RNTP was emailed to the MHPAC on June 14 for comment
- With feedback from CZM, it is more concise than previous Boston RNTPs
- Once an RNTP is submitted by the City to CZM:
 - > there is a 30-day public comment period; and
 - > CZM has up to another 30 days to review comments and issue an NTP



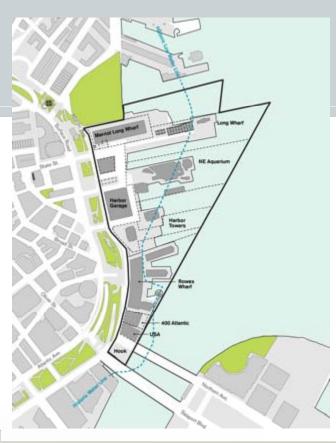


- The NTP:
 - > is the formal state "go ahead" for the MHP;
 - \triangleright issues 31 60 days after an RNTP is submitted; and
 - > may identify additional issues to be considered
- Additional details provided at 310 CMR 23.03
