

## Dudley Vision Project: Community Update August 20, 2008

Dear Dudley Square Community Members & Friends:

I hope that this note finds you well and enjoying summer.

This is to provide update information on Mayor Thomas M. Menino **Dudley Vision Project**. Please feel free to share with those you know who may have interest.

In the summer of 2007, Mayor Menino launched the Dudley Vision Project, a multi-year, City-funded initiative to enhance the thriving retail district of Dudley Square. The project has at its core, three important building elements that will bring state of the art municipal facilities to the neighborhood – a **new Area B-2 Police Station**; a new **Dudley Square Municipal Building** and renovations to the exterior of the Dudley Branch Library.

Additional considerations for this project will result in the creation of a **Dudley Square Strategic Action Plan** to address programmatic areas of transportation, retail, jobs, environment and quality of life.

To collaborate with the team of senior staff from the various City of Boston agencies working on this initiative, Mayor Menino has appointed an advisory task force made up of members of the Dudley/Roxbury community. This group has been at work over the last several weeks becoming organized for the work to be undertaken this fall, and reviewing initial tasks and informational materials provided by the talented consulting firms working on this initiative.

With their involvement, there has been progress with many important components of this project such as:

- **Area B-2 Police Station Design** – Initial programming and design considerations have taken shape for the new police station with the technical expertise of the architecture firm *Leers-Weinzapfel*.
- **Transportation Action Plan & Parking Design Study** – The transportation/engineering team led by the firm *Traffic Solutions* has been engaged by the City of Boston to craft strategies for managing the effects of this important development initiative for Dudley Square. This scope of work will address issues of parking, circulation (vehicular and pedestrian traffic management) through streetscape improvements, and public transportation.

By way of announcement and update, please be advised of the following:

- **Site Preparation for New Municipal Building**

The first phase of work to facilitate creation of the Dudley Square Municipal Building – namely the “part-scale” demolition process for the former Guscott building – is near completion with full removal of materials from that site anticipated by end of August/mid-September.

As has been articulated previously, the exterior of the former Ferdinand Building will be maintained as part of the design for the new municipal site. Work to remove the interior parts of that structure will not be undertaken until design is completed.

- **Site Preparation for Modern Electroplating Building & Property**

To facilitate construction of the new police station and the creation of a new developable site for mixed-use/commercial and retail presence along Dudley Street, the City of Boston, through collaboration between the Department of Neighborhood Development (“DND”) and the BRA, will undertake to remove the long defunct buildings (this includes the former Boston Children Services Center) and to provide for the necessary environmental clean-up of the site.

The City of Boston will initiate a Request for Qualifications (“RFQ”) advertisement process for the environmental clean up within the coming week to seek proposals/bids from experienced and qualified contractors for this important work.

- **Dudley Municipal Building Design Competition**

At the ceremonial demolition this past spring of the former Ferdinand Building, Mayor Menino announced a competition to engage the “best and brightest architectural firms” for the prospect of designing a state of the art municipal building in Dudley Square – this following on the great success of the Dudley Square Design Competition which was sponsored as part of this year’s American Institute of Architecture Annual Conference held in Boston.

Updates regarding an RFQ and parameters for the competition will be forthcoming in Fall 2008.
