








Hyde Square Process








Parking loss around the Monument












- Maximizes usable space to create a civic plaza



Wider Sidewalks & Bicycle Lanes











Bicycle Plan - Climbing Lane







Parking Analysis

Overview

- Weekday parking occupancy & turnover observed hourly between 8 AM and 9 PM
- BTD vehicle equipped with license plate recognition technology captured parked vehicles' location







Parking Study Corridor

- Centre & South Streets from Forest Hills to Jackson Square
- On-street spaces
- Off-street municipal lots







Parking Analysis

Definitions

 Parking occupancy – percent of total spaces filled at a given time

 Parking duration – average length of stay of parked car

Based on observed data












Corridor-wide Parking Analysis


- Forbes Street to Jackson Square
 - 41-74% occupancy
- Moraine Street to Forbes Street
 - 52-85% occupancy
- Pond Street to Moraine Street
 - 25-55% occupancy
- Monument Square to Pond Street
 - 47-99% occupancy
- McBride Street to Monument Square
 - 34-56% occupancy
- St. Mark Street to McBride Street
 - 43-83% occupancy





St. Mark Street to McBride Street

- 86 total spaces
 - Unregulated: 71 spaces
 - 2 hour limit: 15 spaces
 - Avg. duration: 2.04 hours
- Parking peaks after 5 PM
- Primarily residential











McBride Street to Monument Square

- 79 total spaces
 - Unregulated: 21 spaces
 - 2 hour limit: 58 spaces
 - Avg. duration: 2.11 hours
- Avg. duration exceeds regulation
- Peak occupancy 1-4 PM, 7 PM









Pond Street to Moraine Street

- 109 total spaces
 - Unregulated: 53 spaces
 - 2 hour limit: 40 spaces
 - School zone: 16 spaces
 - Avg. duration: 25-55%
- Occupancy drops after 2 PM
- Lowest % occupancy in corridor










Moraine Street to Forbes Street

- 85 total spaces
 - Unregulated: 68 spaces
 - 2 hour limit: 17 spaces
 - Avg. duration: 1.87 hours
- 85% park < 2 hours
- 15% park > 6 hours










Forbes Street to Jackson Square

- 140 total spaces
 - Unregulated: 23 spaces


