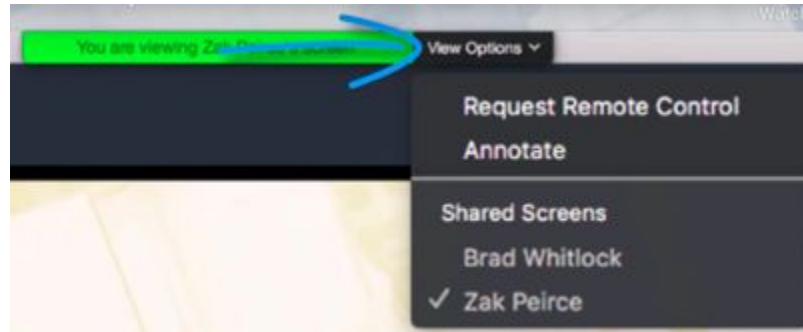

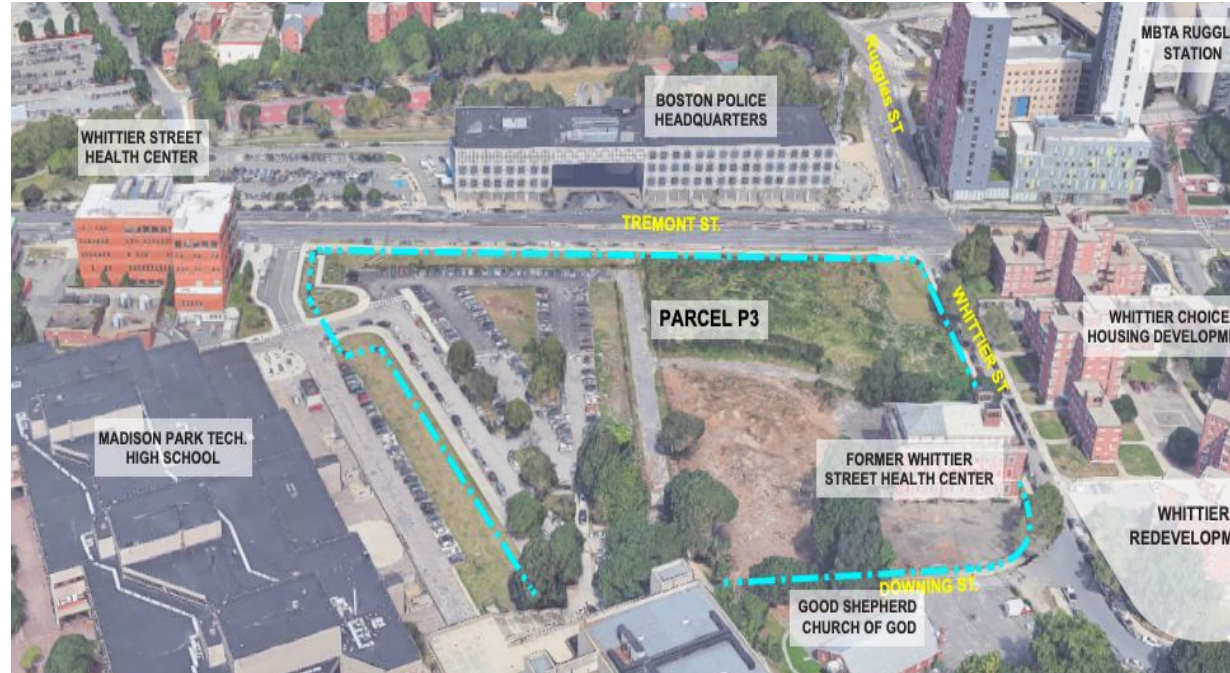

Context

P3 has been occupied by various industrial, commercial, and manufacturing businesses from the late 1880s until the 1960s

- Contaminants include metals, such as lead, as well as other contaminants that come from oil use (polycyclic aromatic hydrocarbons)



Investigations

- 2002 - The first investigation determined what contaminants were in the soil and groundwater, and then evaluated cleanup options but did not implement them



Investigations

- 2016-2017 - The latter investigation found additional contamination across the site
 - Found more oil related contaminants, but also found contamination in the groundwater related to trichloroethylene



Where we are now?

- 2021 - Created a new report that documents all of the previous work and outlines the problems on the whole site and options for clean up
 - Goal would still be remove the hot spots and soil mound
- All contamination is contained within the site and we do not expect any risk to the surrounding community
- BPDA was awarded \$250,000 for remediation
 - Enough to cover targeted soil cleanup, but not enough to cover entire P3 site
- It is anticipated the targeted soil cleanup will include removal of approximately 450 cubic yards of contaminated soil, and take approximately 2 weeks in the field, excavating and trucking.
 - Dust monitoring and dust control techniques will be implemented during this process

Moving Forward

- Targeted cleanup is a good start, but BPDA committed to cleaning up the entire P3 site, which is estimated to cost \$1.3 Million
 - Pursuing all options to fund remediation as quickly as possible through the City, BPDA, and external sources.
- The BPDA will host a series of P3 workshops that will shape its eventual RFP. The next workshop is **Feb 22nd, 2021** and will cover site conditions and visioning exercise.
- Once the RFP has been released the BPDA will accept applications for developers and community members will weigh in on potential designees
