PFC Ernest W. Prussman Medal of Honor Monument Boston College NIF Grant Application – Spring 2015

1) Executive Summary

a. Private First Class Ernest W. Prussman grew up in Brighton (58 Murdock Street) and graduated from Brighton High School. He perished during World War II and received the Medal of Honor (posthumously) for his heroism and conspicuous gallantry in the face of withering enemy fire. To date, PFC Prussman has a small Boston Hero Square sign at the corner of Goodenough and Faneuil Streets in Brighton and nothing else. This is not in keeping with the significance or stature of the Medal of Honor, our nation's highest military honor. A mere ~1800 Medals of Honor have been bestowed since 1865. This endeavor seeks to create a PFC Ernest W Prussman Medal of Honor Monument to be located on the Commonwealth Avenue Carriage Road median between Wallingford and Leamington Roads in Brighton.

2) Organization and Principal Summary

- a. Allston Brighton Veterans is a subgroup of the City of Boston's Veterans' Services. Mayor Walsh announced the creation of the Boston Veterans Advisory Council on December 21, 2014 at an event at the New England Center for Homeless Veterans. Richard Holahan was appointed by Mayor Walsh to serve as the District 9 Liaison representing all of Allston and Brighton on the Boston Veterans Advisory Council. The Boston Veterans Advisory Council advises the City Council and Mayor on veterans' issues in the city and advocates for veterans causes.
- b. Richard Holahan completed his undergraduate studies at Boston College and his MBA from the University of Connecticut. He currently serves in a specialized role in the United States Army Reserve, holds the rank of Captain, and is a Senior Vice President at Citibank. At Citibank, Richard manages global, strategic banking projects with budgets in excess of \$50mm and is adept at project management, change request management, project documentation and artifact generation, governance and oversight, senior reporting, budgeting, and cost control.

3) Other World War II Hero Monuments in Allston Brighton

a. Comparable Project 1 – PFC Stanley Kaplan died during World War II. He has a memorial monument at the corner of Commonwealth Avenue and Washington Street in Brighton. The monument was severely neglected over the years and required \$30,000 of funding to refurbish







- it in 2013. While not seeking to diminish or marginalize PFC Kaplan's supreme sacrifice, it bears mentioning that he did not receive the Medal of Honor as PFC Prussman did. See Appendix A for photographs.
- b. Comparable Project 2 1LT William E Boyden, Jr died during World War II. He has a memorial monument at the corner of Commonwealth Avenue and Lake Street in Brighton near the Boston College MBTA Station. 1LT Boyden's monument is undergoing refurbishment and improvements in 2015. While not seeking to diminish or marginalize 1LT Boyden's supreme sacrifice, it bears mentioning that he did not receive the Medal of Honor as PFC Prussman did. See Appendix B for photographs.

4) Project Details and Location

- a. While the design process is not complete, the intent is to create a stone obelisk with carvings, as well as a bronze panel that describes PFC Prussman's life and his Medal of Honor citation. Also included would be appropriate landscaping and a bench for visitors to sit upon. Examples of comparable projects are available in Appendix C.
- b. In close cooperation with the Office of City Councilor Mark Ciommo and the Boston Department of Public Works' Public Improvement Commission, the proposed site has provisional approval for a monument, which is subject to final approval following an engineering assessment. The site is the Commonwealth Avenue Carriage Road median between Wallingford and Leamington Roads. This is a high-visibility area and aligns with the placement of the PFC Kaplan monument a few blocks east.











5) Project Governance and Oversight

- a. To ensure all constituencies are represented in creating the PFC Ernest W Prussman Memorial, a steering committee will be created with representation by:
 - Rick Holahan Prussman Memorial Steering Committee Chairman (Allston Brighton Veterans)
 - ii. John Laadt Mayor's Office of Neighborhood Services Allston Brighton
 - iii. Mark Handley Councilor Mark Ciommo's Office
 - iv. John O'Brien Boston College Army ROTC Senior Military Instructor
 - v. Sergeant O'Hara Boston Police Department District 14 Community Service Office
 - vi. Ali Carter Brighton Main Streets Executive Director
 - vii. Giselle Stering Commissioner of Boston Veterans' Services
- b. The steering committee will review and approve:
 - i. Design choices and selections via an RFP process (see Appendix C for photos)
- c. Governance / Three-Person Integrity:
 - i. All accounting and use of funds will be reviewed with three-person integrity to minimize fraud, waste, or abuse. At no time will any funds be spent without three-person authorization. A proper accounting and reporting of all funds will be provided to all stakeholders and the general public in the interest of transparency via social media accounts (Facebook).
 - ii. 100% of all requested monies will be used for the Prussman Memorial. No money will be used for salaries, travel, food/drink of the Steering Committee. A small amount (\$100) will be allocated for photocopies in support of recordkeeping and proper accounting.
- d. Project Milestones:
 - i. Fund approval/receipt
 - ii. Conditional approval from the City of Boston to place a monument on Jackson Square
 - iii. Request For Proposals sought from monument designers and artists
 - iv. Steering Committee approves a design and selects an RFP
 - v. Work commences
 - vi. Work completes
 - vii. Dedication / Ribbon Cutting / Ceremony







6) Community Support

a. Attached to the end of this application are nearly 30 letters of support from State Senator Brownsberger, State Representative Honan, Commissioner of the Boston Police Department William Evans, and many other concerned parties who are in favor of a Prussman memorial in Brighton.

7) Other Funding Sources

a. Due to the high visibility and national significance of the Medal of Honor, additional funding sources could be pursued from the Browne Fund, and (if needed) a GoFundMe/crowdsourced methodology.





"For conspicuous gallantry and intrepidity at risk of life above and beyond the call of duty on September 8, 1944, near Les Coates, Brittany, France. When the advance of the flank companies of 2 battalions was halted by intense enemy mortar, machine gun, and sniper fire from a fortified position on his left, Pfc. Prussman maneuvered his squad to assault the enemy fortifications. Hurdling a hedgerow, he came upon 2 enemy riflemen whom he disarmed. After leading his squad across an open field to the next hedgerow, he advanced to a machine gun position, destroyed the gun, captured its crew and 2 riflemen. Again advancing ahead of his squad in the assault, he was mortally wounded by an enemy rifleman, but as he fell to the ground he threw a hand grenade, killing his opponent. His superb leadership and heroic action at the cost of his life so demoralized the enemy that resistance at this point collapsed, permitting the 2 battalions to continue their advance."
