- 5. Charlesview, Inc. incorporated as a non-profit in 1969 to oversee the original Charlesview Apartments. We have been actively engaged in community building and development activities since the redevelopment of the original property in 2013. The Josephine A. Fiorentino Community Center has become a hub for a wide array of activities, services and programs for the North Allston/Brighton community. Charlesview, Inc. has established partnerships with over 20 Allston/Brighton organizations to offer services to the entire community. In addition we host over 80 volunteers annually at the center. Jo-Ann Barbour, Charlesview, Inc. Executive Director brings over 35 years of community building experience and will oversee the Charlesview Summer in the Park program.

Project Information

Since relocating Charlesview to North Brighton we have been committed to playing a role in developing an inclusive, active neighborhood by activating our retail space with restaurants, a pre-school and now a Co-Working organization and developing a wide array of programs and services at the Community Center. We now believe it is time to more fully activate our outdoor space by creating a summer music, movie and outdoor exercise series to provide additional opportunities for Charlesview residents and neighbors to come together to get to know one another, enjoy a variety of music provided by Berkeley College students, watch family movies together and get in shape with an early morning exercise program.

Proposed Project

Charlesview's "Summer in the Park" series will take place on our half-acre greenspace, contiguous to the community center. First, we propose to engage Berkeley students to stage a diversity of outdoor music concerts on the second and fourth Thursdays of June, July and August that will include jazz, bluegrass, blues, pop, funk, African, and Latin. Each night will showcase two different bands playing 45 minute sets that will reflect the diversity of music enjoyed by residents in the North Allston/Brighton neighborhood. We are currently working with Berkeley to identify bands for this summer. Second, we propose to offer a Friday outdoor movie night on June 17, June 24, July 8, July 22, August 5, and August 19 from 8:30 – 10:30 p.m. Movies will be family friendly. Finally, we will contract with Carl Donaldson, a certified personal trainer and martial arts instructor to offer eight weeks of Tai Chi instruction three times per

week at 7:00 a.m. during the months of July and August. All events may be moved into the community center if weather becomes a factor.

Public Benefits

As development in the North Allston/Brighton neighborhood continues to grow it is increasingly important to ensure that the neighborhood remains family friendly and secure. Neighbors who know and care about one another will ensure that this neighborhood will be welcoming and engaged in community life. The goal of this endeavor is to provide increased opportunities for North Allston/Brighton residents to come together in a relaxed atmosphere to better get to know one other, celebrate our diversity, strengthen community cohesion and offer increased activity that will add to the quality of life in our neighborhood.

Additionally, local businesses may realize increased benefits as neighbors and families may include a meal before or after the music and movie evenings.

HAPFRR Funding

We are requesting \$8,850 HAPFRR funding to seed this pilot year of the Charlesview Summer in the Park program to gauge community interest and participation in the activities we propose to offer. If, as we believe will happen, the community embraces the summer park program Charlesview Inc. will commit to fundraising from other sources, including Charlesview, Inc. operating funds to cover the costs going forward on an annual basis.

Timeline

If awarded funding, the program will run from June 9, 2016 through August 25, 2016 activating the park twelve evenings over the summer and three mornings per week during the months of July and August. At the end of the summer we will review neighborhood attendance and solicit feedback from the community with regard to making Charlesview Summer in the Park an annual event.

Project Maintenance

Maintenance of the park is currently a Charlesview operating expense. Over time additional funds may need to be identified to maintain the lawn and plantings.

Sustainability

The Summer in the Park program is sustainable with a funding strategy that includes grants and with business development growing in the neighborhood, business sponsorships that both solidify sustainability of the events and businesses as positive civic neighbors.

Permits

There is no anticipated regulatory review or permitting required for this program. However, Charlesview, Inc. will notify both the Boston Police Department and the Parks Department of the dates and times of the music and movie series.

Budget

The attached budget shows an anticipated total cost of \$9,690 with 91% of the cost (\$8,850) supported by the HAPRFF and 9% supported by Charlesview, Inc. for this first pilot year only.
