Thank you for your review. I'm cc'ing the other members of the IAG here to keep everyone in the loop.

Here are some updates and additional information on the items you mentioned:

- 1. Design of Binford Street intersection: GE has agreed to fund an analysis of the intersection of A and Binford Streets. The Boston Transportation Department will oversee any implementation of this analysis.
- 2. Design of the GE property interface with Fort Point Park: As part of the GE Headquarters project Article 80 approvals process, the BPDA committed to commence the planning and concept design effort for the Fort Point Park. To that end, we will be seeking approval to request authorization to advertise a Request for Proposals (RFP) for design services for the public engagement and concept design for the Fort Point District 100 Acres open space system at the BPDA board on March 2, 2017. We look forward to working with all abutters and the community on this effort in the near future.
- 3. Design of the Necco Court Green Bridge: GE looks forward to working with all interested parties to gather input on the design of the Necco Court bridge.
- 4. The programming and activation of space, programming of watersheet activation, and the provision of boat storage and a dock operator will be included in the Chapter 91 licensing process.
