VOTED: that the Redevelopment Authority endorse the
1965-1975 Building Program for Health and

million city bond issue.

VOTED: that Patten's Restaurant submit their plans for
the development of Parcel 2 H to the Authority
by November 3, 1966.

"In all instances where the BRA is referred to, this shall mean the Boston Redevelopment Authority<sup>11</sup>.

On motion duly made and seconded, it was unanimously

VOTED: that the Development Administrator be and he hereby is authorized, in the name and behalf of the Boston Redevelopment Authority, to execute and deliver an agreement with the Massachusetts Bay Transportation Authority, providing for the MBTA to undertake improvements in the Central

Business District Project Area, such Agreement to be in substantially the form of the Agreement presented to this meeting under cover of the Development Ad.ministrator's memorandum dated September 30, 1966, respecting "MBTA Cooperation Agreement", but with such changes as the Development Administrator deems necessary or desirable, such execution and delivery to be subject to the prior approval of the Federal Department of Housing and Urban Development.

VOTED: that the Development Administrator is hereby authorized to execute and deliver a cooperation agreement between the Boston Redevelopment Authority and the Boston University Medical Center, a medical and educational institution comprised of the Trustees of Boston University, and University Hospital, Inc., both charitable corporations organized and operated not-for-profit under the laws of Massachusetts substantially in the form submitted to the Authority at its meeting held on September 30, 1966, such agreement to be in such form and to contain such other and further terms and provisions as the Development Administrator shall deem proper and in the best interest of the Authority; and the execution and delivery by the Development Administrator of such agreement to which a certificate of this vote is attached shall be conclusively deemed authorized by this vote and conclusive evidence that the form, terms, and provisions thereof are by the Development Administrator deemed proper and in the best interest of the Authority.

VOTED: that the Development Administrator is hereby authorized to execute on behalf of the Authority the design services contract substantially in the form attached hereto with Sasaki, Dawson, DeMay Associates, Inc., the compensation to be paid thereunder not to exceed \$22,700 to be paid for from Project funds.

On motion duly made and seconded, it was unanimously

VOTED: that the Boston Redevelopment Authority hereby congratulates the MBTA Board of Directors and Advisory Board and all other concerned parties and agencies for the excellent cooperative work which has resulted in the Advisory Board's action of September 15, 1966, adopting the MBTA's "Program for Mass Transportation", and further

VOTED: that this Board endorses all of the provisions of
the Plan and further studies which have been acted
upon and offers its continued support in the furtherance of the program.
